The Ministry of Commerce of Myanmar has issued the notification no.63/2020 dated August 28, 2020 according to which the soft opening period started on October 1, 2020 and would end on March 31, 2021. Unless marks are re-filed during the soft opening period they will become invalid after March 31, 2021. There are three options for clients to refile their marks: without cautionary notice, with cautionary notice and with evidence of use. We recommend protecting the marks of our potential clients in Japan by refiling the marks by March 31, 2021.
